Re: Implementation of the order of Hon'ble Supreme Court of India on payment of pension to the Employees and Officers of Regional Rural Banks (RRB)

This communiqué has reference to the Hon'ble Supreme Court judgment dated 25.04.2018 in the matter of SLP-39288/2012 on the issue of payment of pension to the Employees and Officers' of Regional Rural Banks (RRBs). A copy of the same is enclosed for your ready reference.

- 2. All India RRB Officers' Federation, which is an affiliate of All India Bank Officers' Confederation (AIBOC) had requested your good office vide their letter No.2022:24:2018 dated 2th May 2018 and the Additional Secretary (Banking), vide their letter no.2022:37 dated 28.06.18, for implementation of the Order of Hon'ble Supreme Court. However, there has been no positive outcome in the matter, so far.
- 3. Sir, you are aware that the RRBs are functioning as an extended arm of the Government in the rural, semi-urban and remotest parts of the country. They are pioneers in promoting inclusive banking and have been extending yeomen service to the peasants, farmers, rural artisans, landless labourers, and the less privileged sections of the society thereby contributing significantly to foster the growth of agrarian economy of the country. Their stellar performances has received plaudits and accolades from the Government of India on many occasions and have effectively fulfilled the objectives and the purpose for which they have been established.

- 4. We fail to fathom the reason for holding back the legitimate benefit of Employees and Officers' of RRBs despite the clear cut direction to implement the order within a period of 3 months of the receipt of the order, which tantamount to contempt of the Hon'ble Supreme Court of India.
- 5. All India Bank Officers' Confederation (AIBOC), an apex Trade Union of supervisory cadre having more than 3,20,000 members solicits your personal intervention in the implementation of the judgment of the Hon'ble Supreme Court of India.
- 6. We trust that DFS will issue necessary direction to implement this landmark judgment, which would fulfill a long standing demand of Employees and Officers of RRBs.
