STATEMENT OF THE CASE

1. REINSTATEMENT OF COM. P.V. MOHANAN, CHAIRMAN OF DHANALAKSHMI BANK OFFICERS' ORGANISATION AND TAKING OVER OF DHANLAKSHMI BANK BY A PUBLIC SECTOR BANK

We had issued a strike notice on this issue and an understanding was reached between the Management and the Associations including AIBOC in the presence of Shri Ramesh Chennithala, Hon'ble Minister for Home, Government of Kerala. Though the DBOO kept its words and withdrew the 33 days strike, the Management has gone back on its promise to keep in abeyance the termination order. Hence we demand reinstatement of Com. P.V. Mohanan immediately. We had issued a strike notice on 27th November 2015, in which this was one of the demands. In the reconciliation meeting held on 08.12.2015, the IBA was asked by the Dy. Chief Labour Commissioner (Central), Mumbai to collect detailed report from Dhanalakshmi Bank within 15 days and bring it before the Dy. CLC, Mumbai for taking a view on the matter. As this issue was not sorted out, AIBOC along with a broader struggle committee had been agitating infront of Dhanalakshmi Bank Head Quarters at Thrissur for more than 40 days. The issue is related to the whistle blower policy which was pursued by the then General Secretary, Com. P.V. Mohanan. Now, it has come to light that there were huge frauds and even a former member of the Board has been arrested. The Bank is mismanaged because of which it is under constant scrutiny of Reserve Bank of India also. CBI investigations are also going on. Hence to safe guard the interest of the customers, we demand taking over of Dhanalakshmi Bank by a Public Sector Bank as has happened in case of many other Private sector banks earlier.
