## 14<sup>TH</sup> BIENNIAL CONFERENCE AND 33<sup>RD</sup> GENERAL BODY MEETING OF LAKSHMI VILAS BANK OFFICERS' ASSOCIATION

The 14<sup>th</sup> Biennial Conference and 33<sup>rd</sup> General Body Meeting of Lakshmi Vilas Bank Officers' Association was held successfully at Trichy on 2<sup>nd</sup> and 3<sup>rd</sup> October, 2014. The Inaugural Function was held on 2<sup>nd</sup> October, 2014, in aesthetically decorated hall. The Inaugural function started with an invocation at 5.30 pm. After welcoming all by Com. S. Asaithambi, Chairman of the reception committee, all the guest on the dais lighted the traditional lamp to mark auspicious beginning of the Conference.

Pradeep delivered the special address and the Chief Operating Officer, Shri A.J. Vidyasagar spoke about the bank performance, combined efforts of LVBOA and LVBEU in motivating the rank in file and the HR initiative taken by the bank. Com. Thomas Franco of SBOA, Com. Dr. V. Chidambara Kumar of BOIOA and Com. P. Manoharan of LVBEU also addressed the conference and conveyed their best wishes. Com. G.D. Nadaf, Former General Secretary of AIBOC was also present and delivered a motivational address. The vote of thanks was proposed by the General Secretary, Com. K. Gopish and with National Anthem beautifully organized Inaugural Session came to an end.

The Delegate Session was held on 3<sup>rd</sup> October, 2014, commencing at 09.30 am with the presidential address by Com. M. Sivakumar. The General Secretary Com. K.Gopish submitted

The new team was unanimously elected with Com. M. Sivakumar as President, Com. K. Gopish as General Secretary, Com. K.V. Tulsiram and Com. V. Badri as Vice President and Com. K. Sukanya as Treasurer. After the new team was installed in the House, nomination of Com. Sivakumar and Com. K.V. Tulasiram as trustees to the LVB Employees' Provident Trust and the nomination of Com. K. Gopish to the LVB Employees' Pension Fund Trust were unanimously approved by the General Body.

Curtains were drawn to a wonderfully well organized General Body Meeting of the Association with the vote of thanks proposed by Com. K. Gopish and National Anthem by all. It was a curtain raiser of LVBOA's Golden Jubilee Year.
