AIPNBOA HOLDS ITS 23rd GENERAL COUNCIL WITH FULL GRANDEUR

The venue was beautifully decorated and the Volunteers attired in traditional dress were present to welcome all. In the backdrop, band from Rajasthan Riffles played welcome tune.
